**A RESOLUTION TO SET RESIDENTIAL PERMIT FEES BY THE CITY OF ETOWAH
TENNESSEE**

WHEREAS, the City of Etowah being authorized through T.C. A 6-5-501 through 6-5-506 for the purpose of regulating construction, alteration, repair, use and occupancy, location ,maintenance, removal, and demolition of every building or structure, and

WHEREAS, the City of Etowah Municipal Code 150.25 Building Code states that the City Commission my by means of Resolution set the permit fee for the City of Etowah as needed, and

WHEREAS, it is prudent that the City Commission occasionally revise the amount of said permit fees and create new fees so that expenses incurred by the City in supplying certain municipal; services are adequately met by the associated fees;

NOW, THEREFORE, BE IT RESOLVE by the City Commission of the City of Etowah, Tennessee that fees previously established for Building Permit within the City of Etowah, by the City Commission are now revised and set by this Resolution as follows:




