City Commission Meeting Minutes

November 16, 2020

1) Call to Order:

Mayor Burke Garwood called the meeting to order inside the Commission Chambers located at 155 Robinson Street. This meeting was open to public and broadcast on Facebook Live with social distancing, masking, and sneezeguards in place.

Motion carried with a unanimous commission vote.

e. Consideration and Approval of Sale of Obsolete Office Items to List on GovDeals

a. Consideration and Approval of Revised Cost from Boswell Paving for Paving Community Center Parking Lot and Latham Street
